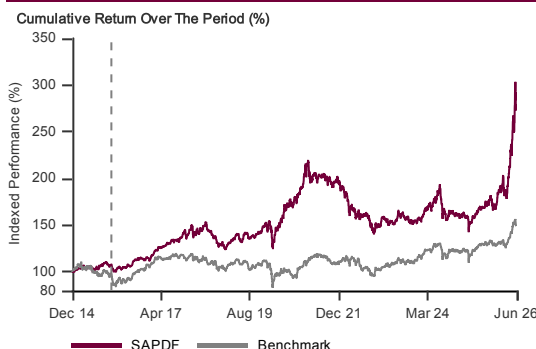

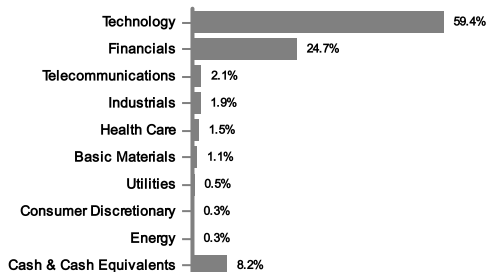

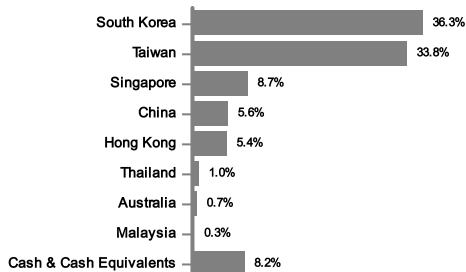

Based on the Fund's portfolio returns as at May 31 2026, the Volatility Factor (VF) for this Fund is 21.8 for MYR Class (Very High), 21.9 for USD Class (Very High), 21.9 for SGD Class (Very High), 22.3 for AUD Class (Very High), 21.9 for GBP Class (Very High), and 21.8 for EUR Class (Very High), and 21.8 for RMB Class (Very High) (source: Lipper). Very Low includes Funds with VF that are not more than 4.705. Low includes Funds with VF that are above 4.705 but not more than 8.735. Moderate includes Funds with VF that are above 8.735 but not more than 11.955. High includes Funds with VF that are above 11.955 but not more than 16.46. Very High includes Funds with VF that are above 16.46. The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. The Fund's portfolio may have changed since this date and there is no guaranteed that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
